- Young professional is defined as individual 35 year-old and under
- Active professionalism in a key utility project or program within a utility
- Accomplishment of an innovative solution to a conveyance or treatment issue faced by a client/employer utility. Operational, financial and engineered solutions will be considered.
- o Participation in professional/community activities supporting utility/community stakeholders.
