YH20 5th Annual Celebration Ceremony

This year marks the 5th time that the joint Baltimore City/CWEA program has honored those students who completed their YH20 training. Those who complete the program are guaranteed employment in the water industry. This year's 17 graduates have already been hired: Baltimore City Department of Public Works – 13; Baltimore County – 2; Howard County – 1; Maryland Environmental Service – 1. Also announced at the event, the YH20 Program had been chosen as a finalist for the Amazon City On A Cloud Innovation grant. Below is an excerpt from the application describing the program expansion and a link to the announcement.

Baltimore City Department of Public Works (DPW): The proposed project seeks to expand DPW, Mayor's Office of Economic Development (MOED), and Chesapeake Water Environment Association (CWEA)'s YH20 Youth Mentorship Program through the introduction of an IT component and its application within the water industry to combat environmental injustice. The IT pilot program will build upon each phase of YH20 by providing professional development and experience for youth in minority and underserved communities throughout Baltimore to ultimately receive long-term employment.
